STALLION SERVICE CONTRACT I, _____ hereby confirm my reservation to the stallion **Epic Eastwood** for the 2026 season to breed the mare named _____. Stud fee for breeding above named mare to this stallion is __\$1,550.00_ which includes a booking fee of \$250 and is for a **live foal guarantee**. First time collection is included in the stud fee. Subsequent collections, if required, are payable directly to Rood & Riddle based on their fee schedule. Shipping is not included and is a pass-through cost depending on location of mare owner.

A \$35.00 fee will be assessed on any returned check.

A 10% discount will be given to repeat mare owners.

If for any reason the mare should need to be re-bred the following season, a new, non-refundable booking fee of \$250, must be paid and received before shipment of semen is requested.

A uterine culture is recommended if you have: an older mare that has previously bred; a mare that had a difficult birth and/or retained placenta; aborted her last pregnancy; or if you have any other reasons to be suspicious of the mare's uterine health. We expect you to follow your veterinarian's recommendation.

I understand that my mare must be examined by a licensed veterinarian between 40 and 50 days after the last day bred and Foxworth Farm (FF) notified of her pregnancy status at that time or all live foal guarantees are null and void.

A breeding certificate will be issued after the conclusion of this breeding season.

This contract guarantees return privileges for the same mare during the course of the Foxworth Farm breeding season. In the event the mare does not conceive, the

mare owner is guaranteed return breeding privileges for one breeding season following the initial breeding season. A second mare may be substituted with permission of stallion owner.

Prior permission from the stallion owner must be given for Embryo transfers. If a mare produces two embryos that result in two foals that stand and nurse, a 50% additional breeding fee will be incurred.

This contract is not transferable without written permission of the stallion owner. Should the mare not produce a live foal that stands and suckles, the mare owner shall be entitled to above-mentioned return privileges. This guarantee shall only apply if the stallion owner is notified within one week of the foal's death. A statement of details by a licensed veterinarian must follow within 10 days or the guarantee becomes null and void. This clause is also binding in case of abortion. If a mare reabsorbs her pregnancy, Foxworth Farm must have written verification of this fact from a veterinarian.

A collection fee and shipping fee will also be required for each additional collection within the same breeding season and is payable to Rood and Riddle prior to collection. The Collection fee is based on the fee schedule for the LeBlanc Reproduction Center at Rood & Riddle Lexington, KY. Additional fees will be required for shipment to Canada. Semen will be shipped in a high-quality disposable shipping box specifically designed for the shipment of fresh cooled semen. Shipping boxes need NOT be returned and should be disposed of properly.

The mare owner understands that requests for semen must be made by 3 P.M. EST via telephone the day BEFORE the requested semen collection. Same day shipping will be accommodated when possible. **Please note semen cannot be shipped via FedEx on Sat. or Sun.** Please inform your vet of this deadline so they can schedule examinations accordingly. **You must contact Robert Jackson, DVM to request semen! Phone: 859-397-2100.**

Fees for collection and shipping will be managed by Rood and Riddle Equine Hospital in Lexington KY.

I understand that the mare owner shall assume all responsibility for the condition of the mare and bear all risk of loss or damage to the mare whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees to hold the stallion owner, keeper or agent harmless for any and all damages associated

therewith. Any disputes of a legal matter must be settled in Woodford County Court in Versailles, KY.

I, the undersigned, do hereby certify that I am the mare owner named herein, or a duly authorized agent thereof, and as such have the authority to enter into this contract, as witness by my signature. I also certify that I have read and understand this contract and fee schedules. This contract is binding upon both parties when signed.
